HB 84 - Relating to issuance and renewal of a driver's license of an elderly person.

HB 90 - Relating to the acceptance of certain identification for release of a motor vehicle by vehicle storage facilities.

HB 191 - Relating to fees for issuance of specialty license plates to members and former members of the United States armed forces and their surviving spouses.

HB 310 - Relating to the transfer of registration and removal of license plates for the sale or transfer of used vehicles.

HB 313 - Relating to an exemption from registration in this state for certain foreign commercial motor vehicles.

HB 320 - Relating to use of electronically readable information from a driver's license or personal identification certificate by a commercial business.

HB 323 - Relating to three-point seat belts on buses that transport schoolchildren.

HB 412 - Relating to erecting or maintaining certain outdoor signs or advertising; creating an offense; providing penalties.
